Status of CAC motions: Open lines of communication with other watershed districts has been fulfilled since Terry attends a Metro wide regulatory working group of watershed administrators that meets quarterly. Standardizing the rules is not possible. Steep Slope Definition: A slope greater than 18% definition already exists. Does this take into consideration Otto Strick's concern of slope vulnerability during heavy rain events? Manger Ziegler suggests resuming monthly meetings with the CAC president.
