

RESOLUTION NO. 22-017
Riley-Purgatory-Bluff Creek Watershed District
Board of Managers

Authorizing execution of cost-share agreement with
Eden Prairie Independent School District No. 272

Manager _____ offered the following resolution and moved its adoption, seconded by
Manager _____:

WHEREAS Riley-Purgatory-Bluff Creek Watershed District's 2018 10-Year Watershed Management Plan identifies chloride (salt) pollution as a critical water-resource challenge in the watershed and a key component of the implementation of the RPBCWD plan (section 9.7) is a program providing cost-share support for chloride-use reduction efforts by local governmental entities and others, including support for projects and actions addressing the Minnesota Pollution Control Agency's Twin Cities Metro Chloride Total Maximum Daily Load study;

WHEREAS at its December 18, 2018, special meeting the RPBCWD Board of Managers authorized execution of the 2019 – Watershed Based Funding Metro grant agreement providing among other support from the Clean Water Land and Legacy Program, and RPBCWD designated \$197,209 of the grant funding for the Lower Minnesota River Chloride Cost-Share Program, to be implemented in collaboration with the Lower Minnesota River Watershed District, Nine Mile Creek Watershed District and the Richfield-Bloomington Water Management Organization; and

WHEREAS RPBCWD staff has received and reviewed the application from Eden Prairie Independent School District no. 272 for cost-share support for the purchase of two truck-mounted chloride-application systems that are expected to reduce the school district's use of chloride de-icing material by 12 to 18 tons, or at least 20 percent from current rates (the Project), and staff finds that implementation of the Project substantially contributes to RPBCWD's plan goals and the purposes of the Lower Minnesota River Chloride Cost-Share Program, and staff recommends not to exceed \$20,000 in cost-share support for the Project as provided in the attached cost-share agreement.

NOW THEREFORE BE IT RESOLVED that **the** RPBCWD Board of Managers authorizes the president to execute the attached cost-share agreement with Eden Prairie Independent School District no. 272 to provide reimbursement of up to 75 percent of the costs of the Project, not to exceed \$20,000.
