

RESOLUTION NO. 22-085

Approving and authorizing the preparation and submittal of a Performance Review and Assessment (PRAP) grant application

Manager _____ offered and Manager _____ seconded the following resolution and moved its adoption:

WHEREAS the recently completed Performance Review and Assessment Program – Organizational Report, October 2022 recommended that RPBCWD “Engage in Mediated Discussions with Third Party to Ensure both the Board and Staff Address Issues that Adversely Affect the Organization; and

WHEREAS the recently completed Performance Review and Assessment Program – Organizational Report, October 2022 recommended that RPBCWD “Evaluate Options for Increased Efficiencies at Board Meetings”; and

WHEREAS the recently completed Performance Review and Assessment Program – Organizational Report, October 2022 recommended that RPBCWD “Conduct a Strategic Assessment to Evaluate the Mission, Vision, and Establish goals and priorities for the future”; and

WHEREAS the recently completed Performance Review and Assessment Program – Organizational Report, October 2022 indicated that only two High Performance Standards were not met, both relating to strategic planning; and

WHEREAS the marking of the halfway point through the current Watershed Management Plan would be a favorable point to begin planning for the next plan; and

WHEREAS, the Board of Managers have indicated at several meetings the desire to undertake a strategic planning effort and work towards an improved working environment; and

WHEREAS, the Board of Soil and Water Resources (BWSR) administers a PRAP assistance grant program for professional services to assist with facilitation or mediation related to organizational strategies.

NOW THEREFORE BE IT RESOLVED that the RPBCWD Board of Managers authorizes the District Administrator to prepare and submit an application to BWSR for a PRAP grant to deal specifically with the recommendations contained within the PRAP – Organizational Report, and, with the assistance of Smith Partners, staff at the Minnesota Board of Soil and Water Resources, and other individuals and entities who may have knowledge of the process, identify qualified organizations and consultants that specialize in assisting organizations comport with the provided recommendations.
