CITIZENS ADVISORY COMMITTEE**

**RESOLUTION APPROVING CREATION OF FRIENDS OF RPBCWD**

Sharon McCotter\_offered the following resolution and moved for its adoption, which was seconded by Heidi Groven

**WHEREAS** the Riley Purgatory Bluff Creek (RPBCWD) Board of Managers (BOM) and the Citizens Advisory Committee (CAC) have indicated that it is important that other ecological services, such as woodland management, terrestrial invasive species control, and establishment of native ecosystems are managed for the many benefits they serve; and

**WHEREAS** members of the CAC have stated an interest in being more involved with hands-on conservation activity and partnering with existing organizations to foster good land and water stewardship throughout the district; and

**WHEREAS** the formation of an ad hoc subcommittee, to be called the Friends of Riley Purgatory Bluff Creek Watershed District could serve to provide this opportunity; and

**WHEREAS** participation in this subcommittee would be voluntary; and

**WHEREAS** the initiation and administration of the subcommittee would be the labor of the members of the subcommittee and not require additional financial or staff resources with exception of what is needed to provide the resources the subcommittee will need to meet the goals of this resolution unless authorized by a majority vote of the BOM; and

**WHEREAS** the CAC and the members of this subcommittee understand that they are not allowed to represent the BOM or the RPBCWD except as allowed by the most recently adopted Governance Manual or as authorized by the BOM.

**NOW THEREFORE BE IT RESOLVED** that the Citizens' Advisory Committee of the Riley Purgatory Bluff Creek Watershed moves to authorize the formation of a subcommittee to be known as the Friends of Riley Purgatory Bluff Creek Watershed District and that its members reach out to similar groups and organizations to inform them of their existence and to find opportunities for community engagement and partnership for the preservation, restoration, and protection of natural resources within the district.
