**Authorizing Payment to Minger Contracting of Requested Amount in Pay Application #2
for St Hubert's Water Quality Improvement Project**

Manager _____ offered the following resolution and moved its adoption, seconded by
Manager _____:

WHEREAS Riley-Purgatory-Bluff Creek Watershed District developed and adopted a watershed management plan pursuant to Minnesota Statutes section 103B.251 which identifies potential projects including a water quality and stormwater abstraction project to improve water quality in Rice March Lake watershed;

WHEREAS at its October 2, 2019 meeting, the RPBCWD Board of Managers adopted a plan amendment to include water quality best management practices on the campus of St Hubert's Catholic School (the Project) in accordance Minnesota Statutes section 103B.314; and

WHEREAS at its February 2, 2020 meeting, the RPBCWD Board of Managers ordered the Project in accordance with Minnesota Statutes section 103B.251; and

WHEREAS at its May 10, 2021 meeting, the RPBCWD Board of Managers awarded the Project to Minger Construction; and

WHEREAS legal counsel for the RPBCWD Board of Managers drafted an agreement which was subsequently executed by the District Administrator; and

WHEREAS the work completed by Minger Construction indicated in pay application #1 was confirmed by the contractor, the design engineer SRF Consulting, and the District Administrator

WHEREAS Minger Construction has completed the work indicated in the pay application and this has been confirmed by the contractor and the District Administrator; and

WHEREAS RPBCWD has levied funds and budgeted for this project.

NOW THEREFORE BE IT RESOLVED that the RPBCWD Board of Managers authorizes the Treasurer and accountant to submit payment to Minger Construction in the amount of \$5,783.00.
