- **A.** District Updates (staff)
 - 1. General:
 - a) Projects (Liz): EHAP update TAP includes partner cities, USFWS, NRCS, Carver SWCD, Anne Marie Journey, 25 people RSVPd. First workshop on "What is a healthy urban ecosystem?" Liz shared draft maps from Barr Eng, including lawn surface area (approx 44% of district), historic and current tree cover, light pollution, population vulnerability, undeveloped land, habitat quality... etc. First TAP workshop May 18. Dave Paulson asked if the EHAP Barr report will be made public. Liz said that, once final, reports/summaries will be made available. Eventually there will be opportunity for the public and CAC to provide input.
 - b) New AIS Control webpage: rpbcwd.org/AIScontrol. Postcards sent to property owners adjacent to treatment areas. Permit webpage updated as well.
 - 2. E&O: (Liz for Eleanor)- Tree/shrub saplings arrived and placed into gravel beds so root systems can develop over summer. Giveway in fall.
